JACOB'S VILLAGE COMMUNITY CENTER PLANNED FOR 2016

Have you heard the news? Jacob's Village has embarked on an exciting project – plans for a much-needed community center are well underway. The 3,700 square foot building will be the centerpiece of our expanding neighborhood, and will offer the space and amenities that have long been part of our vision: a multipurpose room that will accommodate 50 people, a reception area and social gathering space, an exercise/therapy room, and computer workstations for residents' use, as well as administrative offices, a catering kitchen, badly needed storage space and a covered outdoor patio. The center will be within comfortable walking distance of our residents' homes and fully accessible to those in wheelchairs, walkers and

scooters. Ample parking will be available for visitors.

Active minds and bodies, and meaningful relationships with others, are critical to our residents' well-being. We currently have no indoor space large enough to comfortably house social gatherings and group activities, which are confined to the living room in one of our homes. When the activities include volunteers and visitors, it often is so crowded that groups must be split, and some activities are simply not possible. Jacob's Village receives NAP Tax Credits

By making a donation to Jacob's Village (\$100 or greater), you will be able to utilize Neighborhood Assistance Program Tax Credits - allowing you to get half of your contribution back as a TAX CREDIT on your Indiana taxes next spring, with the option of also claiming the entire gift as a deduction on your itemized federal tax return. Not only will you get a great break on your taxes next April; you'll provide funding for the agency. This means that your gift will be worth more than twice as much as it actually costs you. Here's an example: If you give a gift of \$100, you will make a check out to Jacob's Village for the whole amount. Along with the contribution, you'll complete some paperwork that we will send into the state on your behalf. Several weeks later, the state will send you a letter that indicates you have a tax credit for \$50 (or half of whatever you have donated over \$100). That means, when it comes time to pay your state taxes next April, you will pay \$50 less; or if you don't owe anything, you'll get \$50 back! If you also file an itemized federal tax return, you can also then claim a deductible contribution of the entire \$100, which will save you even more. So your \$100 gift will actually only cost you \$50 or LESS! What counts as a contribution? Cash, checks, stocks, securities, or certain stationary building materials are permitted contributions.
